What we collect

We may collect the following information:

- contact information including email address

What we do with the information we gather

We require this information for your booking confirmation, invoice and contact before, during and after your stay about your booking or payment. Gathering this information is required by the Finnish law on accommodation and catering activities 2006/308 §6 (*Laki majoitus- ja ravitsemistoiminnasta 2006/308 §6*).

We will not sell, distribute or lease your personal information to third parties unless we have your permission or are required by law to do so. Data is not transferred outside the EU or the European Economic Area.

From time to time, we may use your email address to send a newsletter. You will have the possibility to unsubscribe through the newsletter.

Security

We are committed to ensuring that your information is secure. In order to prevent unauthorized access or disclosure, we have put in place suitable physical, electronic and managerial procedures to safeguard and secure the information we collect.
